

Walworth County Announcement Farmers, Homes, Businesses 2020 Clean Sweep Event



Walworth County is sponsoring a Clean Sweep program to help household residents, businesses, schools and municipalities properly dispose of damaged, banned, unusable, and unwanted products that contain hazardous chemicals and pesticides. These items are generally marked Caustic, Acid, Danger, Flammable, Warning, or Poison. <u>This program does NOT take electronic items, appliances, latex paint, medications or tires.</u>

Friday, October 2, 2020 – 8:00 AM to 12:00 Noon Businesses & Farmers ONLY VSQG & Agricultural Hazardous Waste ONLY – Chargeable

Any business, municipality, school, or service provider that generates small amounts of hazardous waste, and classifies as a Very Small Quantity Generator (VSQG) according to DNR standards are allowed to participate in this program. VSQG and Agricultural program participants are required to pay for product disposal, which is considerably less than contracting individually for this service. This program is cost-effective and convenient.

<u>*PRE-REGISTRATION is required</u>. Anyone interested under this VSQG or Agricultural program, must preregister with Veolia by <u>Monday, September 14, 2020</u> and provide them with a list of products you want to dispose. Certain restrictions apply – Veolia will provide details upon request.*
