LEAF PICK-UP and DROP - OFF

Grass, weeds, leaves, and small sticks in PAPER COMPOSTABLE bags and SMALL bundles of sticks may be dropped off near the Town Hall in Zenda by Friday, May 13th.

Leaf pick-up will be May 14th and November 19th for homes with Monday garbage pick-up.

Drop-off in Zenda by Friday, November 18th.

BULKY PICK-UP

Starting June 1 and through August 30, homes with Monday garbage collection will have weekly "bulky" pick up. Bulky collection for homes with Wednesday pickup will be on the second collection of the month. All homes have weekly garbage and recycling pick up throughout the year.

COMPUTER / ELECTRONIC RECYCLING

Household electronics, including TV's and computer monitors, may be brought to the Town complex in Zenda, on Saturday, August 13th, between 9:00 a.m. and 1:00 **p.m.** John's Disposal will collect and recycle these items at no cost. You will be asked to give your name and Town of Linn address.

NEW BOAT LAUNCH PAY MACHINES

The Town of Linn is installing pay machines at both Town boat launches - Hillside Road and Linn Road. Daily and annual passes can be purchased at the machines. The machines accept debit and credit card payments only. The machines will dispense a receipt to display on your vehicle dash. Passes can still be purchased in cash or check at the Town Clerk's Office during business hours.

Resident veterans or active-duty military can pickup free launch pass cards at the Clerk's Office. Verification is required.

A daily or annual launch fee is required for all motorized and/or trailered watercraft at both Town boat launches. Daily launch fees are paid prior to launch. Launch fees are required for non-motorized & trailered watercraft - such as canoes, kayaks, and SUPs. Launch fees are applicable to both Linn residents and non-residents.

BEACH PASSES

Beach passes for the Village of Williams Bay beach are available to Town of Linn residents. Two free passes are available per household. To obtain a pass, you must provide proof of Linn residency, like a property tax bill in your name, and a valid form of ID to the Village of Williams Bay office at 250 Williams Street. TOWN ANNUAL MEETING – TUESDAY, APRIL 19

The Town's Annual Meeting is scheduled on Tuesday, April 19th, 7 p.m., at TOWN HALL. Residents must pre-register by Sunday, April 17th at 10 p.m. Inperson attendees are NOT required to pre-register.

LINN HIGHWAY

The Town will resurface over 3 miles of road for the third year in a row! The following roads/subdivisions are scheduled to be resurfaced: Black Point Rd.; Wooddale Dr.; Fair Oaks Rd.; Wildwood Rd.; Springbrook Rd.; Orchard Rd.; Old Farm Rd.; Hill Rd.; Forest St.; Summit Rd. - from Border to Hillcrest.

In addition to resurfacing, the Town will provide maintenance work, such as crack filling, flex and infrared patching, chip seal work, or a pavement rejuvenation chemical, to portions of the following roads/subdivisions: South Lakeshore; Solar Ln; Lackey Lane; Academy Rd; Hillcrest Dr.; Ingalls Ln.; Academy Rd.; Hillcrest Dr.; Ingalls Ln.; Academy Ln.; Hilltop Dr.; Bluebird Dr.; Grove St.; Oak St.; Snake Rd.

HOUSEHOLD CLEAN SWEEP

Friday, October 7, 3:00 p.m. - 5:00 p.m. at the Town of Linn Highway Shop, N611 Zenda Road, Zenda. Vehicles must enter from County Highway B on Mill Road. A route map will be posted to the Town website.

Residents can bring most household products labeled "hazardous, caustic, acid, danger, flammable, warning or poison" for disposal. NO electronic items will be accepted. There is a link to Clean Sweep on the Walworth County website. In mid-September local newspapers and the Town's website will have more complete information on what is acceptable. You can also check with the Walworth County Solid Waste Division.

DOG LICENSES

Full-time Town residents must license their dogs. The yearly fee is \$32 for a male or female dog or \$13 for a neutered male or spayed female dog. After April 1, a \$5 late fee is added to each license. Licenses are available at the Clerk's office with proof of current rabies vaccination.

STORM SIRENS

Storm warning sirens are located throughout the town and are tested on the third Wednesday of the month at noon. The test will sound for about 3 minutes. In the event of severe weather, the siren will sound, signaling to take cover and tune to a local radio or television station for detailed information. The sirens are serviced yearly. If you do not hear a siren on a test day, please contact the Clerk's office.
